HURRICANE LAURA RESPONSE

- Established Disaster Relief Fund, raising over \$92,000
- Worked to secure disaster supplies receiving nearly \$56,000 in donations
- Coordinated over 650 volunteer hours for disaster relief
- Secured volunteers and helped sort and package disaster supplies
- Coordinated and worked pet food distribution
- Coordinated and worked two lunches and one dinner distribution
- Co-hosted major supply distribution with The Salvation Army to serve over 700 families
- Coordinated over 50 volunteers for a two-day MARC event by Orange County Disaster Rebuild
- · Posted frequent social media updates to inform the community about resources



COVID-19 RELIEF

United Way of Orange County's COVID-19 Relief Fund was able to help our community in two ways. First, we were able to work through our Partner Agencies to get \$19,600 to individuals in need. Second, we were able to provide \$18,250 to our Partner Agencies who suffered a loss of funding due to COVID-19. We also held a food drive which was able to help stock five local food pantries.

Our Corporate Partners and Community Members assisted nine Partner Agencies with projects to support their clients.
